The FLSA does not require overtime pay for work on Saturdays ...

The federal Fair Labor Standards Act mandates that employers must compensate employees for time and a half for each hour worked over a 40-hour workweek. An employee who makes \$10 an hour and works 41 hours in a given week would be paid \$400 plus an additional \$15 to cover the time and a half hour of overtime she worked.

Labor matters in the UAE are regulated by Federal Law No. 8 of 1980, or the “Law,” amended by Federal Laws No. 24 of 1981, No.15 of 1985 and No.12 of 1986.
