The Colorado estate tax is based on the state death tax credit, which until 2005 was allowable on federal estate tax returns. The state death tax credit is calculated as a percentage of the value of the federal adjusted taxable estate, which is calculated as the fair market value of all assets gifted to another individual less certain deductions.
