The Land Law (Ireland) Act 1881 gave tenants real security, though by this time the Irish were demanding proprietorship. The Act established the principle of dual ownership by landlord and tenant, gave legal status to the Custom of Ulster throughout the country, provided for compensation for improvements and created the Irish Land Commission and a Land Court .

Northern Ireland: Land Law

A joint tenant is not entitled to convey land held in joint tenancy or acquire another interest in such land without first obtaining the consent of the other joint tenancy under Section 30 of the Land and Conveyancing Law Reform Act 2009, and any such conveyance is void at law and in equity.
