Local Government (Urban Authorities) Act of 1982 [Act Number 8 of 1982] provides for the establishment, composition, functions and legislative powers of the urban based local government authorities (urban councils) in Tanzania. The urban council is comprised of the governing bodies for townships, municipalities and City Council (Commission).

The Statutory Bodies Financial Arrangements Act 1982 provides that local governments must first obtain the Treasurer's approval prior to entering into financial arrangements such as forming a company, entering into a trust, providing loans to community organisations and council-owned entities, and providing guarantees and indemnities.

The Audit Commission was established under the Local Government Finance Act 1982, to appoint auditors to all local authorities in England and Wales and it became operational on 1 April 1983. The National Health Service and Community Care Act 1990 extended the remit of the Commission to cover health service bodies.
