In Europe, the legal doctrine of droit moral or moral rights gives authors the ability to claim a right of attribution in their works. However, even in Europe, droit moral lawsuits are not routinely used to provide a remedy for garden variety plagiarism.

Moral rights of authors refer to a bundle of legal rights for protection of the honor and reputation of an author. Moral rights receive their fullest expression in French and German law, and two moral rights were added in 1928 to the Berne

An author who has transferred copyright without retaining these rights must ask permission unless the use is one of the statutory exemptions in copyright law. The copyright holder controls the work. Decisions concerning use of the work, such as distribution, access, pricing, updates, and any use restrictions belong to the copyright holder.

Authors may post their articles in full on personal or employer websites ASM grants the author the right to post his/her article (after publication by ASM) on the author's personal or university-hosted website, but not on any corporate, government, or similar website, without ASM's prior permission, provided that proper credit is given to the original ASM publication.

Moral rights. They include the right of attribution, the right to have a work published anonymously or pseudonymously, and the right to the integrity of the work. The preserving of the integrity of the work allows the author to object to alteration, distortion, or mutilation of the work that is "prejudicial to the author's honor or reputation".

The right of attribution recognizes an author's right to be credited as the author of his or her work. The right of integrity recognizes an author's right to prevent prejudicial changes to or distortions of his or her work.
